6 **RESOLUTION NO. R02-24**

7 A resolution authorizing the Mayor to execute an Agreement with the  
8 Louisiana Department of Transportation and Development (LA DOTD) for  
9 improvements at the Slidell Airport.

10  
11 WHEREAS, Act 451 of the 1989 Regular Session of the Louisiana  
12 Legislature authorized the financing of certain airport improvements from funds  
13 appropriated from the Transportation Trust Fund, and  
14

15  
16 WHEREAS, the City Council of the City of Slidell is requesting funding  
17 assistance from the LA DOTD for the installation and commissioning of replacement  
18 Non-Directional Radio Beacon (NDB) equipment, and upgrades, as necessary, of the  
19 antenna system at the existing north NDB site; and

23 WHEREAS, the LA DOTD is agreeable to the implementation of this project and  
24 desires to cooperate with the City Council of the City of Slidell according to the terms  
25 and conditions identified in the attached Agreement; and

28 WHEREAS, the LA DOTD will provide the necessary funding for  
29 equipment purchase, and will reimburse the sponsor up to Ten Thousand Dollars  
30 (\$10,000.00) of the actual installation and commissioning costs.

33 NOW THEREFORE BE IT RESOLVED by the Slidell City Council that it does  
34 hereby authorize the Mayor to execute an Agreement for improvements to the Slidell  
35 Airport identified as State Project No. 977-99-0115, more fully identified in the  
36 Agreement attached hereto.




