6 A resolution ordering a special election to be held in the City of Slidell, St.
7 Tammany Parish, Louisiana, for the purpose of electing a new City Council Member from
8 Councilmanic District B to fill the vacancy and unexpired term created by the resignation of
9 Council Member Jerry Binder.

10 WHEREAS, the City of Slidell by resolution passed this day recognizes a
11 vacancy will exist in the Slidell City Council from Councilmanic District B, City of Slidell, St.
12 Tammany Parish, Louisiana; and

14 WHEREAS, the governing authority for the City of Slidell is given the
15 authority and responsibility under the provisions of Louisiana Revised Statutes 18:602 and
16 Slidell Home Rule Charter Section 2-03, Paragraph C, to fill the vacancy and the position
17 of City Council Member by special election when an unexpired term exceeds one (1) year;

23 WHEREAS, the said vacancy results in the creation of an unexpired term in
24 excess of one (1) year.

26 NOW THEREFORE BE IT RESOLVED by the Slidell City Council that it does
27 hereby authorize and call a special election to be held in the City of Slidell, St. Tammany
28 Parish, Louisiana, for the purpose of electing a City Council Member to fill the vacancy to
29 be effective at 11:59 a.m. on January 12, 2004, for the unexpired term of Council Member
30 Jerry Binder from Councilmanic District B.

34 BE IT FURTHER RESOLVED that the qualifying period for said election shall
35 be from January 28 through January 30, 2004, inclusive, and that the primary election shall
36 be held on March 9, 2004, with a general election, if necessary, held on April 17, 2004,


