6 A resolution providing for canvassing the returns and declaring the results of
7 the special election held in the City of Slidell, State of Louisiana, on Tuesday, November 2,
8 2004, to authorize the renewal of special taxes therein.

9 BE IT RESOLVED by the Slidell City Council (the "Governing Authority"),
10 acting as the governing authority of the City of Slidell, State of Louisiana (the "City"), that:

12 SECTION 1. Canvass. This Governing Authority does now proceed in open
13 and public session to examine the official tabulations of votes cast at the special election
14 held in the City of Slidell, State of Louisiana, on TUESDAY, NOVEMBER 2, 2004, to
15 authorize the renewal of special taxes therein, and the Governing Authority does further
16 proceed to examine and canvass the returns and declare the results of the special election.

20 SECTION 2. Procès Verbal. A *Procès Verbal* of the canvass of the returns of
21 said election shall be made and a certified copy thereof shall be forwarded to the Secretary
22 of State, Baton Rouge, Louisiana, who shall record the same in his office; another certified
23 copy thereof shall be forwarded to the Clerk of Court and *Ex-Officio* Recorder of Mortgages
24 in and for the Parish of St. Tammany, who shall record the same in the Mortgage Records
25 of said Parish; and another copy thereof shall be retained in the archives of this Governing
26 Authority.



8 BE IT KNOWN AND REMEMBERED that on Tuesday, November 16, 2004,
9 at six-thirty o'clock (6:30) p.m., at its regular meeting place, the City Hall, 2055 Second
10 Street, Slidell, Louisiana, the Slidell City Council (the "Governing Authority"), acting as the
11 governing authority of the City of Slidell, State of Louisiana (the "City"), and being the
12 authority ordering the election held therein on Tuesday, November 2, 2004, with the
13 following members present:

15 the Council and Council Members Pearl Williams, Rickey Hursey, Landon Cusimano, Kevin

32 police department of the City, including the acquisition of the
33 necessary equipment therefor?

9 **GARBAGE TAX RENEWAL PROPOSITION**

11 SUMMARY: AUTHORITY TO RENEW A TEN (10) YEAR FIVE (5)
12 MILLS PROPERTY TAX FOR CONSTRUCTING AND
13 MAINTAINING GARBAGE DISPOSAL WORKS AND REFUSE AND
14 GARBAGE COLLECTION AND DISPOSAL SYSTEMS WITHIN
15 AND FOR THE CITY.

16 Shall the City of Slidell, State of Louisiana, levy a five (5) mills tax on
17 all property subject to taxation in said City for a period of ten (10)
18 years, beginning with the year 2006 and ending with the year 2015,
19 for the purpose of constructing and maintaining garbage disposal
20 works and refuse and garbage collection and disposal systems
21 within and for the City?

- 4 (i) There was a total of **7,805** votes cast **IN FAVOR OF** Proposition No. 1
5 and a total of **4,272** votes cast **AGAINST** Proposition No. 1, as
6 hereinabove set forth, and that there was a majority of **3,533** votes cast
7 **IN FAVOR OF** Proposition No. 1 as hereinabove set forth; and
- 8 (ii) There was a total of **7,643** votes cast **IN FAVOR OF** Proposition No. 2
9 and a total of **4,340** votes cast **AGAINST** Proposition No. 2, as
10 hereinabove set forth, and that there was a majority of **3,303** votes cast
11 **IN FAVOR OF** Proposition No. 2 as hereinabove set forth; and
- 12 (iii) There was a total of **7,297** votes cast **IN FAVOR OF** Proposition No. 3
13 and a total of **4,725** votes cast **AGAINST** Proposition No. 3, as
14 hereinabove set forth, and that there was a majority of **2,572** votes cast
15 **IN FAVOR OF** Proposition No. 3 as hereinabove set forth.

16 Therefore, the Governing Authority did declare and proclaim and does hereby
17 declare and proclaim in open and public session that Proposition No. 1, as hereinabove set
18 forth was duly **CARRIED**, that Proposition No. 2 as hereinabove set forth was duly
19 **CARRIED**, and Proposition No. 3 as herein above set forth were duly **CARRIED** by a
20 majority of the votes cast by the qualified electors voting at the said special election held in
21 the City on Tuesday, November 2, 2004.
