12 within the City of Slidell through the Road Home program; and



A resolution authorizing the Mayor of the City of Slidell to execute transfer documents relative to Louisiana Land Trust properties.


WHEREAS, the Louisiana Land Trust has acquired two additional properties within the City of Slidell through the Road Home program; and


WHEREAS, the City has decided to take title to 2076 6<sup>th</sup> Street and 145 South Street; and
