7 A resolution approving the extension of City water and sewer services beyond
8 City limits to the property located at 1700 Daney Street, Slidell, Louisiana, pursuant to City
9 of Slidell Code of Ordinance, Section 2-35, conditioned upon annexation of said property
10 into the City of Slidell.

11 WHEREAS, AT&T is desirous of annexing property located at 1700 Daney
12 Street, Slidell, Louisiana, into the corporate limits of the City of Slidell; and

14 WHEREAS, AT&T has submitted a Petition for Annexation with the City of
15 Slidell; and

17 WHEREAS, AT&T desires that pending the application and approval of
18 Petition for Annexation, the City extend City water services beyond the City corporate
19 limits to property located at 1700 Daney Street, Slidell, Louisiana; and

22 WHEREAS, AT&T shall be responsible for and timely pay all costs associated
23 with the installation and connection of said water line in addition to all monthly usage fees;

27 WHEREAS, City desires, subject to the foregoing, to extend City water
28 services to said location, conditioned upon approval of AT&T's Petition for Annexation; and

30 WHEREAS, City reserves the right to immediately withdraw City water and
31 sewer services to said location, should, for any reason whatsoever, the Petition for
32 Annexation be withdrawn or denied; and

4 WHEREAS, City reserves the right to immediately withdraw City water and
5 sewer services to said location, should for any reason whatsoever, the Petition for
6 Annexation not be approved within one (1) year of filing of same.

9 NOW THEREFORE BE IT RESOLVED by the Slidell City Council that it does
10 hereby expressly approve the extension of City water and sewer services to the property
11 owned by AT&T, 1700 Daney Street, Slidell, Louisiana, pursuant to Ordinance, Section 2-
12 35, conditioned upon annexation.

15 BE IT FURTHER RESOLVED that the City reserves the right to immediately
16 withdraw City utilities to the property owned by AT&T located at 1700 Daney Street, Slidell,
17 Louisiana, should the Petition for Annexation be withdrawn for any reason or should
18 Petitioner fail to participate, in a timely fashion, in accordance with the annexation process.

21 BE IT FINALLY RESOLVED that the City reserves the right to immediately
22 withdraw City water Services to the property owned by AT&T located at 1700 Daney
23 Street, Slidell, Louisiana, should, for any reason whatsoever, the Petition for Annexation
24 not be approved within one (1) year of filing of same.
