9 WHEREAS, the Mayor has recommended partial City sponsorship of the
10 American Cancer Society's Relay For Life which is currently scheduled to be held in
11 Heritage Park on April 9, 2016, and annually thereafter; and

14 WHEREAS, the City Council agrees with partial City sponsorship; and

16 WHEREAS, the City Council passed Ordinance No. 3165 on February 10,
17 2004, which required that any events sponsored by the City of Slidell be approved jointly
18 by the Mayor and the Council; and

20 WHEREAS, the procedure involves the completion of a "City Sponsored
21 Event" application by the entity seeking sponsorship; and

24 WHEREAS, the form is then sent to the requisite City Department heads as
25 determined by the Administration in order to provide internal cost estimates and availability
26 of labor and accommodations for said event; and

29 WHEREAS, the form is then forwarded to the Mayor for his approval or
30 denial; and

32 WHEREAS, upon the Mayor's approval the form is forwarded to the
33 Council for consideration by Resolution.

35 NOW THEREFORE BE IT RESOLVED by the Slidell City Council that it
36 does hereby concur with the recommendation by the Mayor to partially sponsor the


